Daarul Hijrah Foundation has several institutions, namely Daarul Hijrah Islamic Boarding School (PPDH), Daarul Hijrah Islamic Kindergarten, Daarul Hijrah Tahsin and Tahfidz Quran Institute (LTTQ). All programs and activities are free for Orphans and Dhuafa with funds sourced from donations from donors. The Daarul Hijrah Foundation has two focal points for fostering students, namely religious education and entrepreneurship education as stated in the mission of the Daarul Hijrah Foundation of South Sumatra.

RESULT AND DISCUSSIONS

Activity Form

1. Evaluation Results of Santri Education PP Daarul Hijrah Odd Semester 2021/2022 In January 2022, there were five PPDH boarding students studying at UIN Raden Fatah Palembang who had received KHS (Study Result Card) for the odd semester of the 2021/2022 academic year with very good results. Likewise, two of the boarding students who go to school are ranked first and second in their class.

Fitria got all A's from 7 courses, Jamila got one B grade from 9 courses. then Abdullah got one B grade from 10 courses, Syabudin got one B grade from 9 courses and Marwansyah got two B grades from 9 courses taken.

In addition, Nurjenita, a boarding student who studies at MTs Aisyiyah Balayudah, grade 8, received 1st place out of 23 students. And M. Dimas Ghiandra Al Furqon, who attends Qurania Junior High School Palembang in 9th grade, ranked 2nd out of 27 students. Alhamdulillah, the learning results of these boarding students become an evaluation material to maintain good grades and be improved for the better in the future. The hope is that the learning process on campus or school and learning activities at the Foundation can be a provision for younger santri to become smart individuals for a better future.

2. Addition of boarding students at PP Daarul Hijrah

In February 2022, there were two new boarding students in the Daughters Dormitory of Pesantren Daarul Hijrah (PPDH). First, Dina Amelia Sestika Miranda who came from Padang Ganting, West Sumatra. In March 2022, the activity of Tausyiah Welcoming the Month of Ramadan 1443 Hijriyah was held on Thursday night Friday, March 24, 2022 at Mushollah Al-Fikri Daarul Hijrah Foundation IV (four) Jakabaring.

The event began with reading surah Yaasin together bada maghrib prayer, then remarks and continued with tausyiah welcoming the arrival of the holy month of Ramadan delivered by Ust. Dr. Bitoh Purnomo, Lc. Bitoh Purnomo, Lc, M.A. The event was attended by religious leaders, community leaders, local RT heads, Wakif Daarul Hijrah Jakabaring, the Board of Trustees, Chairman and Management of the Daarul Hijrah Foundation, congregation of Al-Fikri mushollah, and local residents.

This event aims to invite the community to prepare themselves in terms of faith and physical health in anticipating the arrival of the holy month of Ramadan 1443 Hijriyah. So that by preparing themselves, it is hoped that they can explain fasting optimally, and can carry out a series of other worship services which in turn can harvest the rewards in the holy month of Ramadan this year.

4. Distribution of Ramadan Food Packages

In April 2022, which coincided with the month of Ramadan 1443 Hijriyah, Daarul Hijrah Foundation received the trust of Islah Bina Umat Foundation Jakarta to distribute basic food packages in three mosque locations that had been built from donors of Islah Bina Umat Foundation Jakarta before.

The first location was at the Al Mukhlishin Mosque of the Daarul Hijrah Foundation in Tanjung Api-Api with 40 food packages. The second location at the Al Hamzah Eight Ilir Kenten mosque as many as 17 food packages. And the third location at the Al Multazam mosque, Daarul Hijrah Kalidoni Foundation, totaling 44 food packages. One basic food package consists of 5 kg of rice, 2 kg of flour, 2 kg of sugar, 2 liters of vegetable oil, 20 bks of instant noodles, syrup, tea boxes, milk, and canned sardines. The food packages were given to mosque administrators and people in need around the location.

This activity is a form of cooperation between Daarul Hijrah Foundation South Sumatra and Islah Bina Umat Foundation Jakarta as a partner in providing social assistance and Islamic preaching to the community that has been going on since 2018. It is hoped that activities like this can continue to be carried out in a sustainable manner every year. So that there are more benefits that we can provide to the people.

5. Teaching and Learning Activities After Eid Al-Fitr Holiday 1443 H

In May 2022 after the Eid al-Fitr 1443 Hijri holiday, teaching and learning activities at LTTQ Daarul Hijrah were held again starting Monday, May 9, 2022. All boarding students of Daarul Hijrah Islamic Boarding School have also returned to the dormitory and returned to active school or college.

Then on Thursday, May 12, 2022 LTTQ Daarul Hijrah Kalidoni and Tanjung Api-Api students have entered and studied as usual. Then on Tuesday, May 17, 2022 LTTQ Daarul Hijrah Pakjo and Jakabaring students were also actively studying again. LTTQ Daarul Hijrah teaching and learning activities in four locations, namely Pakjo, Tanjung Api-Api, Kalidoni and Jakabaring take place with the same learning schedule as before Ramadan. Learning activities start from noon to night every Monday-Friday.

With the resumption of post-Ramadan teaching and learning activities at the Daarul Hijrah Foundation, hopefully the spirit of worship in the past Ramadan can continue to exist in every student and istiqomah in seeking knowledge so that they are more confident and obedient to Allah SWT.

6. New Boarding Student at Daarul Hijrah Jakabaring Dormitory for Boys

In June 2022 there was an addition of a new boarding student in the Daarul Hijrah Putra Dormitory in Jakabaring, namely M. Dimas Ghiandra Al-Furqon. Dimas, as he is familiarly called, has been registered as a non-resident student at the Daarul Hijrah Islamic Boarding School since March 2021. Previously, Dimas was in grade VII (seven) at Qurania Junior High School Palembang. However, his parents lost their jobs due to the impact of the Covid-19 pandemic. So, he could not continue his schooling due to financial constraints. Then the Daarul Hijrah Foundation of South Sumatra provided tuition assistance for Dimas so that he could continue his schooling in grade VIII (eight) of Qurania Junior High School Palembang.

Dimas has now graduated from junior high school and will continue his studies at Madrasah Aliyah Negeri (MAN) 1 Palembang, which has passed the test through the regular route. Dimas will start school on July 18, 2022, he lives in the Daarul Hijrah Jakabaring male dormitory along with two other male students. Thus, the total number of male and female PPDH boarding students at this time is 11 people. The hope is that by studying at MAN 1 Palembang, Dimas will become an outstanding student at school, become an independent santri and have a strong Islamic character

CONCLUSION

The Daarul Hijrah Foundation of South Sumatra is a social, educational, and religious foundation that operates several institutions, including Daarul Hijrah Islamic Boarding School, Daarul Hijrah Islamic Kindergarten, Daarul Hijrah Tahsin, and Tahfidz Quran Institute.
